## Evaluation Methods Used:

Destination Colorado Meetings was evaluated using Google Chrome v. 126.0.6478.127 on a Windows Desktop Computer, Google Chrome v. 126.0.6478.127 on a Macintosh Laptop Computer, Mozilla Firefox v. 127.0 on a Windows Desktop Computer, and various other technologies and browsers as simulated by LambdaTest.

Assistive technologies used in this evaluation included NVDA (screen reader), and the Windows screen magnification function as well as exclusive use of the keyboard to navigate and operate the site content and functionality. Other tools used included Lighthouse (Google Developer Tools), SiteImprove Website Accessibility Checker, and AccessiBe accessibility auditing tools.
